Minutes of the Last Meeting

7th November 2017- the minutes were approved.

Items for discussion today

GPC UK Conference, 9th March 2018. Attending Dr E Jessup, Phil White, Sara Bodey, Tim Davies, Dr Jonathan Jones to attend as an Observer.

Speakers 3.30pm Gary Davies from Vision – options for information sharing and cluster working.

Mr Davies, Regional Account Manager for Vision covers four health boards including BCUHB. Gary described the 360 system in use throughout the UK. There is a need for more localised care, cluster working, sharing with other healthcare professionals and less pressure on GPs. The 360 system is an assured partner of EMIS and shares data between clinicians and is fed back to the GP records. It is possible to specify certain information not to be shared.

Neath have a HUB shared service, where patients can be referred to physio, pharmacy etc with a shared appointment web based system.

Caerphilly LHB want District Nurses to have access and use windows on their laptops so that they can use on the road, this is underpinned by a data sharing agreement. As long as there is internet access patient records can be shared. The system is fully audited and only certain individuals will have a log in.

Andy Swinburn and **Dr Brendan Lloyd** (Medical Director) Welsh Ambulance Service Advanced Paramedic Practitioners and their potential role within Community Paramedic Schemes.

Calls from Healthcare professionals is the number one reason for calling an ambulance, peak times are Monday to Friday 1pm.

There are three pilots in BCUHB since November 2017 to include 2 rapid response vehicles and a Paramedic. They have devised a rotational model for Paramedics. The three active schemes are in BCUHB, Cwm Taf and Cardiff and Vale. In the Cwm Taf scheme four clinicians are working in GP practice in order to reduce conveyance and admissions to ED and free up GP time, patients are referred to virtual ward, care plan developed by a MDT.

Clinical supervision by WAST, GP and HB. In Cardiff and Vale two clinicians work in GP practice.

They are also piloting a scheme using Paramedics in a Practice to help with unscheduled care.

2.10 Items needing a decision today

Medicines Management Enhanced Service – issues raised from the East Area, what do we as an LMC want to do with regarding this scheme in the future? Dr Sara Bodey stated that there were two issues regarding the overall budget and the rising costs of medications. Also unachievable targets have been set.

They had been told in the East that any reduction in antibiotic prescribing would be over ridden by finance. Dr Alison Hughes stated that there was an agreement to look at a pilot whereby at cluster level they would hold their prescribing budget.

Items for discussion today

- a) **2.25** Indemnity/Welsh Risk Pool Cover situation for doctors looking after community hospital patients. Dr Jessup has written to all GPs to let them know about the fact that colleagues providing service to patients in community hospitals might not be covered by the Welsh risk pool indemnity as there was a change in April 2015, those GPs need to contact their MDefence urgently to arrange appropriate cover retrospectively as well as going forward. This has only just come to light. Doctors covering community hospitals on a sessional basis or OOH are unaffected, however, it would be wise to get written confirmation from the LHB to ensure that the work is covered.
