Minutes of the Last Meeting

9th January 2018- the minutes were approved.

Speakers 2pm Mrs Sue Owen, Care Closer to Home.

This focuses on supporting health and wellbeing so that the patient can return to the life they choose. Collaborative partnerships with the public, WAST, Local authorities, police, fire service, carers, public health, housing associations, the independent sector and universities should plan together, share assets, have one point of access and try to reduce duplication.

She described the service provision of a model cluster serving a population of 50,000.

The expected number of GPs would be 25, 11 pharmacies, 7 dental surgeries, 6 clinicians.

They have held stakeholder events where most of the ideas formed the CCTH.

The aim of the Community Resource Team is to pull all the resources together.

Health and Wellbeing Centre Services comprise of three levels. Level 1 to include advanced diagnostics, rehab, minor injury service, OPD, access to Multidisciplinary teams, telehealth, access to a Consultant (virtual ward round), triage, social prescribing and health promotion, level 2 will have all the above except for the first 4.

EJ stated that he is now two years into a four year term and feels it is time for change.
JN wished to thank EJ for his excellent Chairmanship.

Items for discussion today

Oxygen cylinders/ambulance delays and cost implications to Primary Care.
Intolerable and dangerous delays in the ambulance service. SB concerned that there are not enough oxygen cylinders supplied to practice. Only one cylinder in urban practices and two in rural areas.
Members related cases where there were emergencies and ambulances late in arrival. Dr Liz Bowen requested such cases to be reported to her. She needs to gather anonymized examples.

Dr P Emmett queried what the algorithm is for ambulances.
C Close – as a group we need to look at our emergency practices.

I.T. Procurement.

Hopefully data transfer will go smoothly.
Some practices will need tuition with the new Vision system. The change will be over the next eighteen months.
